






RECOMMENDED SOLDERING PATTERN






RELATIVE INTENSITY vs. WAVELENGTH





SPATIAL DISTRIBUTION













REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS




Notes:




REEL DIMENSION (units: mm)
